First day to circulate Opportunity to Ballot Petition.....Tuesday, March 19, 2019  
Last day to file Opportunity to Ballot Petition.....Midnight, Thursday, April 11, 2019  
Last day to file OTB Petition if designated candidate declines.....Midnight, Thurs., April 18, 2019  
Last day to file general objections to OTB Petition.....(3) days after petition filed  
Last day to file specifications of objections to OTB Petition.....(6) days after objections filed  
(If last day is a Saturday or Sunday, then file by midnight of the following Monday)

Last day to institute Judicial Proceedings regarding Opportunity to Ballot Petitions.....14 days  
after the last day to file an OTB Petition **OR** (3) business days after BOE hearing where OTB  
petition is invalidated
